### Preconsidered State Legislation Resolution 2

**State Legislation Resolution requesting the New York State Legislature to pass bills introduced by Senator Gounardes, S.5744, and Assembly Member Pheffer Amato, A.6156, "AN ACT to amend the retirement and social security law, in relation to service retirement benefits for certain members of the New York city employees' retirement system".**

**Whereas,** Bills have been introduced in the New York State Legislature by Senator Senator Gounardes, S.5744, and Assembly Member Pheffer Amato, A.6156, "AN ACT to amend the retirement and social security law, in relation to participation in certain retirement plans by active and retired members and staff of the New York city council"; *and*

**Whereas,** The enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; *now, therefore, be it*

**Resolved,** That the Council of the City of New York, in accordance with the provisions of Section 2 of Article 9 of the Constitution of the State of New York, does hereby request the New York State Legislature to enact into law the aforesaid pending bills.
