**Whereas**, Bills have been introduced in the New York State Legislature by Senator Senator Jackson, S.6293, and Assembly Member Pheffer Amato, A.6538, "AN ACT to amend the retirement and social security law, in relation to a child care leave credit for New York city uniformed correction officers who are members of
