Whereas, Bills have been introduced in the New York State Legislature by Senator Jackson, S.6976, and Assembly Member Pheffer Amato, A.7420, "AN ACT to amend the retirement and social security law, in relation to the eligibility of certain participants in the New York city employees' retirement system to opt into
