A Local Law to amend the New York city charter, in relation to the role of trees and the tree canopy with

respect to the city's long-term sustainability planning

Be it enacted by the Council as follows:

Section 1. Paragraph 1 of subdivision b of section 20 of the New York city charter, as amended by local

law number 84 for the year 2013, is amended to read as follows:

1. develop and coordinate the implementation of policies, programs and actions to meet the long-term

needs of the city, with respect to its infrastructure, environment and overall sustainability citywide, including

but not limited to the categories of housing, open space, trees and the tree canopy, brownfields, transportation,

water quality and infrastructure, air quality, energy, and climate change; the resiliency of critical infrastructure,

the built environment, coastal protection and communities; and regarding city agencies, businesses, institutions

and the public;

§ 2. This local law takes effect immediately.
